My parish offers and promotes the following accommodations at Mass:		
	Sensory Friendly Mass (Low lighting, no music or quieter selection of instruments (piano, strings), shorter homily, no incense, gluten free options, freedom to move around and stigma free)—optional worship for persons living with autism, Down Syndrome, dementia, Alzheimer's and all community members are invited to attend	
	LOOP System (Assisted Listening System)	
	ASL- (American Sign Language)	
	Braille Materials provided to all blind community members in need	
	Large-print missals/large print worship aids low-gluten hosts or communion from the chalice	
	Cut-out pews that allow wheelchair seating with others	
	Trained greeters, ushers, staff, and volunteers to assist those in need	
	Children and adults with disabilities are trained and serve in ministerial roles and can be assisted by family/staff if desired
