The USCCB Recognizes a New Threat

The Hyde Ammendment and similar laws have been protecting taxpayers from funding elective abortion for 45 years. Now, our president and members of Congress want to take away these laws that both Democrats and Republicans used to support for nearly half a century.

The Hyde Ammendment has been signed into law every year since 1976, whether the Congress and the White House were led by Republicans or Democrats. In 1979, the Supreme Court held in *Maher v. Roe* against the idea of a right to a free abortion when it ruled that *Roe v. Wade*, "implies no limitation on the authority of a State to make a value judgment favoring childbirth over abortion, and to implement that judgment by the allocation of public

funds." Even President Obama recognized the need for that kind of compromise when he signed an exeutive order pertaining to the Affordable Care Act and taxpayer funding of abortion. Today, according to a **recent poll**, a majority of Americans still opopose using taxpayer money to fund abortions. This year, however, for the first time, there is an

explicit call for the Hyde Ammendment to be repealed.

Protecting conscience rights is one reason to support keeping the Hyde Ammendment in place, so that prolife Americans aren't forced to pay for something that ends human life. In addition,

it is fair to presume that when something is sudsidized, it will become more common. Estimates vary, but the Charlotte Lozier Institute in 2016 estimated that the Hyde Ammendment had already saved over 2 million lives.

Lebanon Makes History

On May 25, by unanimous vote of city council, the city of Lebanon became the first Sanctuary City for the Unborn in Ohio. This means that, by city ordinance, not only is it unlawful to procure or perform an abortion, but also to possess or distribute abortion drugs. While there is no abortion facility within the city of Lebanon, this ordinance also restricts the growing use of the abortion pill.



Mark Harrington, President of Created Equal and the director for the Ohio initiative, said, "Joe Biden has stated he wants abortion in every zip code in America. Hence, citizens across America are acting by preventing abortion from being committed in their communities!"

Mark Lee Dickson, Founder of Sanctuary Cities for the Unborn, said, "Cities must be prepared. The future of the abortion industry is not necessarily brick and mortar but abortion by mail or abortion by vending machine at a school or outside of a grocery store."





Bicentennial Pilgrimage 2021

The Marian Pilgrimage has been a wonderful opportunity for renewal and devotion to Christ through the Blessed Mother here in the Archdiocese of Cincinnati, and it has been such a privilege to be a witness to the faithful participation of so many individuals and families. The first week of the Pilgrimage, the Office for Persons with Disabilities led an "Adaptive Rosary Prayer Service" at



Bremenfest Park in New Bremen. Families began to gather early in anticipation of the arrival of the pilgrims and the statue of Our Lady. They brought roses to place on the platform, and there was quite an enthusiastic welcome when the pilgrims finally arrived. We used large, poster-sized images for each of the prayers and mysteries of the Rosary, and it was almost completely led by children in the community. They held up the posters that were sometimes larger than the children holding them and led the prayers with great reverence. Sometimes an extra Hail Mary was recited and occasionally some of the words of the prayers were mistakenly omitted, but it was ab-

solutely one of the most holy experiences of my life. Seeing so many children with such a heart for their faith was inspiring. It was almost as if I could hear Jesus saying, "Let the children come to me."

This Pilgrimage offers an opportunity for every person in our Archdiocese to participate in some capacity. There are daily events along the route that provide prayerful occasions for everyone to be engaged more deeply in their faith. Check the map to find a parish near you that is hosting an event and bring the whole family or a couple of friends. There is a page for the Deaf Community with ASL Resources and a list of events that are accessible for the Deaf. There will be more of the Adaptive Rosary Prayer Services throughout the Pilgrimage that offer an experience for families with children or persons with intellectual and developmental disabilities to pray with visual aids and simplified language. Walking With Mom Kara Ross

Last year, we celebrated the 25th anniversary of Evangelium Vitae, the encyclical by Pope Saint John Paul II. With the anniversary of this pivotal document, the USCCB Respect Life Secretariat also launched the WALKING WITH MOMS IN NEED initiative to help parishes better support women in crisis pregnancy. Often, people who are prolife are accused of simply being pro-birth. While the issue of abortion is at the crux of the prolife movement, prolife people know that we are in this to help both baby and the mother.

The program is set up to be a year of service that the parish dedicates to helping women facing crisis pregnancies. In one year, a parish can create a core team and become an ongoing resource for those facing uncertain circumstances. It is never too late to begin this year of service! The Diocese of



Fort Worth in Texas is about to launch this program and we are praying that many lives are saved through their ministry. As we explore what it looks like to worship Together, it is important for our parishes to take pause and extend an invitation to persons with disabilities and their families. One excellent way to demonstrate that a parish community truly welcomes persons with disabilities is to host regularly scheduled Sensory-Friendly Liturgies. These liturgies are not difficult to implement. They only require some small accommodations such as lower lighting, softer music, and the use of a Children's Lectionary for a more literal interpretation of the readings; but by simply setting aside a regularly scheduled Mass to directly invite persons with sensory needs, you can send a message to persons with disabilities and their families that they are wanted and expected at your parish.

The Office for Persons with Disabilities has all the resources needed to assist parishes in implementing these basic changes to make Mass more accessible to persons with autism, Down Syndrome, Alzheimer's Disease, dementia, and other intellectual and developmental disabilities.
