The Abortion on Demand Act

The Women's Health Protection Act passed the House last September, and just came up for a vote in the Senate on Monday, February 28. Deceptively named, it has nothing to do with women's health, and everything to do with calling access to abortion a "fundamental right" that deserves to be protected in every state through federal statute. Not only would it allow abortion on demand at every stage of pregnancy, but the WHPA would also eliminate popular prolife restrictions—including things like parental notification laws, bans on late-term abortions once a baby can feel pain, and safety regulations specific to abortion facilities. It would effectively nullify any state's ability to restrict abortion and open up allocating tax dollars to pay for it here and abroad.


The U.S. Conference of Bishops WROTE A LETTER to the U.S. Senate last week in advance of the Senate vote. Penned by Archbishop William Lori, Chairman of the Committee of Pro-Life Activities, and Cardinal Timothy Dolan, Chairman of the Committee for Religious Liberty, they wrote, "Abortion is the opposite of

women's health care, and is an extreme violation of human rights...Answering the needs of women by promoting taxpayer-funded elective abortion, as this bill would do, is a failure to love and serve women. Offering free or low-

cost abortions, instead of the resources needed to care for her child, is not 'choice' but coercion. It communicates to a mother in need that there is no hope for her or her child and perpetuates injustices that drive mothers to end the lives of their children."

Senate Majority Leader Chuck Schumer announced the

vote last week, going so far as to call the right to abortion "sacred" when he said, "We are here to...affirm five sacred words: Abortion is a fundamental right." There was no real concern the motion to vote would actually reach the 60 vote threshold necessary to avoid the filibuster, and that motion did fail in the Senate 46-48. While it is not clear why Schumer decided to



ability to restrict abortion. The other thing this accomplished was that it forced Senators to go on record on the issue, which may effect key Senate races at mid-term elections. You can go online yourself—see how your representative voted HERE, and how your senator voted here—and use that information as part of your discernment with your

own voting choices as well. In the words of our bishops, we need "to put the energy and resources behind policies that fully recognize and support both mothers and their children." Let us continue to urge our legislators to heed that call in our work on the local and national levels.

Reviv- A Ministry of Support

When we choose life, we expect to be choosing a sweet, happy and healthy baby. But what happens when that baby is not healthy? We know that all life is sacred, but this reality can be incredibly scary and uncertain. *I know*.

My first child, Vivian, was born on July 4, 2012 and died a short 59 days later on September 21, 2012. She seemed absolutely perfect on the outside, but her 20 week ultrasound revealed that her heart was broken. All too quickly my husband and I realized our presence and the support we received during our hospital stay with Viv was the exception. Children and babies cried alone all day. We would hear parents share their fear and anxiety about their child's future as they were already drowning in the reality of life outside the hospital.

Leaving the hospital without Vivian, my arms were empty. But in this new vocation of motherhood, my heart was full with a need to do something to be a support for other families. Shortly after Vivi died, **Reviv** was born. The mission of **Reviv** is to build a community of care around families who have a child with medical complexities and to help bridge gaps between hospital and home.

Following our unique Family Support Model, **Reviv** is able to create a personalized practical support plan for families that meets their specific needs. Whether it be light house work, encouraging phone check-ins or activities for siblings, **Reviv** builds a community of love that supports families with medically complex kiddos as they choose life everyday.

Lent starts this week! On Ash Wednesday, we receive ashes on our foreheads to remind us of our mortality and need for repentance. In addition, we offer sacrifices or perhaps take on more positive activities during the entire season of Lent to help us grow closer to God. Below are some ideas on what you could do to make 2022 a Pro-Life Lent for you and your family:

- 1. Sign up for a shift at **40DaysforLife.com** in either **CINCINNATI** or **Dayton**.
- 2. Instead of your typical rosary, pray the **USCCB ROSARY FOR LIFE**.
- SPIRITUALLY ADOPT A CHILD in danger of abortion. If you have younger children, Holy Heroes has a free 9-month prayer adventure for you! Sign up online at https://holyheroesspiritualadoption.com/.
- 4. Donate items to your **LOCAL PREGNANCY CARE CENTER** or to other social agencies that provide direct assistance to women in difficult situations.
- SUPPORT PROJECT RACHEL_to help fund advertising and keep retreat costs down for post-abortive women.
- 6. Donate non-perishable items to your local food pantry, or otherwise support other social agencies that help children and families after birth.
- Contact your representative on important legislative issues in Ohio, such as opposing the DEATH PENALTY and supporting the HUMAN LIFE PROTECTION ACT.
- 8. Take some time to volunteer with our PRISON MINISTRIES.

Pregnancy Loss

Pregnancy loss is real loss. If the excitement of life is real prior to birth, so is the pain of death, yet our indifference causes so many to suffer in silence.

To better support them, we must acknowledge the



grief. Ask how they are feeling. Rather than thinking that the shorter the life the less there is to grieve, recognize that grief also includes what could have been. Be prepared to minister to a family just as you would the death of an older child. Offer a memorial service. If your parish has a cemetery, designate a space for families to bury remains.

For the vast majority of my life, I didn't know that World Down Syndrome Day existed. And if you would have told me that thousands of people around the world celebrated Down syndrome, I would have said you were crazy. But four years ago, that all changed when I gave birth to my second child—and she was born with Down syndrome.


Alice entered the world bright and early on St. Patrick's Day in 2018. When she was about an hour old, my husband and I received her Down syndrome diagnosis. We cried a lot. I thought my life was over.

As time went on, we saw firsthand that Down syndrome was nothing to fear and actually so much to embrace. Alice's differences made her beautiful. Her unique gifts made her stand out. Her presence swiftly changed me into a better version of myself. And my life was far from over—in fact, it had really just begun.

Four years ago on World Down Syndrome Day, I sat in a hospital room crying because my four-day-old daughter had Down syndrome. This year on World Down Syndrome Day, I will hug my daughter tightly, kiss her gently and celebrate every single thing about the beautiful reality of Down syndrome.

Project Rachel

Since the pandemic began, much of our outreach with Project Rachel was put on hold. This past January we were finally able to get back out in the community and start visiting high schools in-person again! We spent two days at Moeller High School where we visited the entire Junior class. The students learned about Project Rachel and the impact abortion can have on a person's life. Teacher and coach, Jerry DiCristoforo, left us with a wonderful reflection on how our presentation impacted his students:

"We have enthusiastically welcomed Project Rachel into our religion classes the last few years because it is a wonderful example of who the Church is Called to be! Project Rachel embodies how the Church is Called to be pastoral and ministerial, while challenging the faithful to find Christ in their lives-especially during our greatest struggles. The Project Rachel presentation respects and promotes the Catholic Church teaching that abortion is morally wrong and sinful, but also humanizes the issue so that the students realize that each person involved is a human being that is in need of healing, forgiveness, and to be embraced-not rejected- by the Church. The witness story shared by Project Rachel challenges us to try to understand those who make the decision to have an abortion, rather than to simply judge them. Our students have been deeply touched by these presentations, and have grown in their desire to respond to those who are hurting and in need.

I would encourage every high school to bring Project Rachel into the classroom. I am confident that their students will benefit from the experience."
