COLLECTION DATES AND MAJOR FEASTS - UPDATED CALENDAR

Due to the COVID-19 pandemic, two collection dates that were scheduled to take place this past April were rescheduled for later this year. Good Friday Collection (for the Holy Land) was rescheduled to September 13, 2020 and Catholic Relief Services was rescheduled to November 8, 2020. MONTHLY BILLINGS BEGIN IN JULY

Beginning in July 2020, the parish general assessment and parish property and liability billings for **fiscal year 2020-21** will be sent monthly. The initial billings will be estimated until all parish financial reports are reviewed and the annual calculations are completed. Once the calculations are complete, the remaining billing statements will be adjusted to reflect the actual cost. This should help parishes by spreading these expenses over twelve months. The due date for paying the second half of the **fiscal year 2019-20** parish general assessment remains at September 30, 2020.

FLEXIBILITY IN REQUIREMENTS RELATED TO FORM 1-9 COMPLIANCE

The Department of Homeland Security has temporarily relaxed the requirements around physically viewing work authorization documents for purposes of completing the Form I-9 during the COVID-19 pandemic. You can find more information around this temporary change on the Human Resources webpage.

WORKING STUDENT GUIDELINES

This document is intended to provide school administrators and pastors information about employment of students **during** and **after** school and **through** the summer months. Students under the age of 18 are considered minors and may not work at anything that is hazardous or injurious to their health and well-being, including: activities involving flammable substances, gases, vapors or fumes; activities involving driving a school bus, motor van or any motor-propelled vehicle. 5G TECHNOLOGY AND THE IMPACT ON PARISH MICROPHONE SYSTEMS

The major phone and internet providers are all upgrading to 5G technology. While their negotiations with the FCC may have a great benefit for cell phone users, this technology will negatively impact frequencies which are used in many wireless microphones in churches and schools. All this will become effective July 13, 2020. The FCC notes that this will especially impact those systems which operate on frequencies 617-652 and 663-698 (churches) and frequencies 617, 653-698 (schools). The Pastoral Center of the Archdiocese has followed, and continues to follow, the standards encouraged by the Ohio Department of Health. This applies to youth athletics for the 2019-2020 spring sports season. Following is the official release from the Ohio Department of Health on May 14:

SPORTS LEAGUES (NON-CONTACT, LIMITED CONTACT): MAY 26

Beginning Tuesday, May 26, sports leagues in Ohio will be permitted to operate if these leagues can meet **required safety protocols**. This applies only to non-contact and limited-contact sports. To ensure that non-contact and limited-contact sports leagues operate in the safest manner possible, Governor DeWine's <u>Adult and Youth Sports Leagues Advisory Group</u> is creating a detailed list of guidelines and best practices for sports leagues to follow. A full list of mandatory and recommended best practices will be available soon at <u>www.coronavirus.ohio.gov</u>. Safety protocols for high-contact sports are in development.


